ROBOT

The international word 'robot' was coined more than 100 years ago for the 1921 sci-fi play, Rossum's Universal Robots (R.U.R.), written by the Czech sibling duo of authors, Karel and Josef Čapek. Even back then, they imagined robots were beings created by biochemistry and not simply creatures made of sheet metal and full of gears. Although the first industrial robots did not start operating until many decades later, they already had a name.



CONTACT LENSES

Contact lenses were created thanks to the world-famous Czech scientist and inventor, Otto Wichterle. In the 1960's he laid down the foundation for today's soft lenses, which are used by over 100 million people around world. Because of the then Communist regime's stance, he had to make the equipment for the first prototype from a children's building kit and a dynamo from his sons' bicycle.



NANOFIBER

Czech scientist, Oldřich Jirsák, invented a technology that, since 2003, has enabled faster and cheaper production of non-woven nanofiber textiles, thus starting their industrial production. Thanks to this, nanofibers are used in fields such as medicine, where they help in the development of artificial blood vessels and bandages. Additionally, they are used in the garment industry and for water purification.

Dear friends,

At the beginning of July, 2022, the Czech Republic will take over the EU Council Presidency for the second time, 13 years after its premiere. of Industry of the Czech Republic regards all of these to be crucial for successful economic and social recovery of Europe, and for becoming even stronger for the future.

The Czech Republic takes over the Presidency of the Council of the EU at a time when Europe must overcome not only the COVID-19 pandemic, but also the consequences of the recent Russian military aggression against Ukraine. For the international community the situation in Ukraine represents a crisis of the rule of law and democracy. Given its global economic impacts, it is also a society-wide crisis, which citizens and companies have to face and whose total effects are not yet possible to be fully quantified.

Thus the European Union must re-think its strategies and initiatives now and rationally reflect the current situation. Once the urgent humanitarian crisis is successfully handled, measures of mid-term and long-term effects must follow, aiming at reassuring stability and Europe's economic prosperity. Bearing all of this in mind, the Confederation of Industry of the Czech Republic formulates its three fundamental priorities for the upcoming six months. The most representative Czech confederation of entrepreneurs and employers puts emphasis on strengthening European resilience while keeping its openness, ensuring its competitiveness and sustainable development, and on further development of the dynamic EU labour market.

We in the Confederation of Industry of the Czech Republic are convinced that coordinated efforts of all social partners and Member States can assist the European Union and the entire international community to overcome this demanding period together and to find a successful way of coming out of it stronger.

FIRST PILLAR



A RESILIENT AND OPEN EUROPE

STRENGTHEN THE OPEN STRATEGIC AUTONOMY OF EUROPEAN INDUSTRY, ITS RESILIENCY, AND DIVERSIFICATION

- Reduce unilateral dependencies, ensure the diversification of value chains and strengthen European security via effective international cooperation and the expansion of trade agreements network.
- > While strengthening common defence and security policies pay attention to effective co-operation and search for synergies between the public and private sector and support for the European defence industry and cybersecurity.
- > When establishing regulations, pay heed to balancing the EU's level playing field and openness, i.e., prevent protectionism.
- > Translate the updated industrial strategy into specific steps contributing to the growth of competitiveness of European industry and

strengthen its own production in strategic areas.

Realise green and digital transformation in a way that is consistent with implementing the European industrial strategy as well as with the EU's global competitiveness.

AMBITIOUS EU TRADE POLICY AND EFFECTIVE MULTILATERALISM

- > Strengthen the synergy and coherence between EU trade policy and other EU policies, in the interest of implementing the EU's priorities regarding external relations and supporting the competitiveness of European companies and digital transformation (ambitious digital chapters in trade agreements).
- > Actively promote solutions based on a broader international consensus (e.g. finding solutions in the area of taxation within the OECD), and in specific cases respect the possibilities of using the individual countries' economic policy support instruments.
- > Encourage the ratification of trade agreements by realistically setting their scope and emphasising their economic objectives, including a balanced approach towards negotiations and better communication regarding their positive impact on job creation, among other things.
- > Promote strategic partnerships with an emphasis on transatlantic cooperation. It is necessary to focus on securing safe international data transmission and cooperation in the area of modern technology.

- In the interest of preserving the multilateral trade system, in cooperation with the USA and other key countries, promote the fully functioning World Trade Organization and its modernisation.
- Support the candidate status for Ukraine, promote Eastern Partnership and the European perspective of the Western Balkans.

SECOND PILLAR



A COMPETITIVE AND SUSTAINABLE EUROPE

THE GRADUAL PATH TOWARDS A CLIMATE-NEUTRAL EU, TAKING INTO ACCOUNT ITS EFFECTS ON THE COMPETITIVENESS OF INDUSTRY

- Primarily ensure European energy security and stability of energy supplies.
- > Provide for co-ordination of common purchases and projects related to key energy and raw material inputs, as well as a balanced approach to individual EU Member States.
- Respect technological neutrality, transitional technology, and investment cycles.
- > Stipulate contributions to the EU's climate and energy goals by the Member States, according to their national specifications and economic capabilities.
- Maintain and strengthen measures against carbon leakage.

- > Utilise digital technology for ecological transformation.
- Set the "Fit for 55" package realistically, and not at the expense of the competitiveness of some Member States.

DEEPENING AND IMPROVEMENT OF THE EU'S INTERNAL MARKET

- > In compliance with the EU's long-term Action Plan for better implementation and enforcement of the single market rules, increase the effectiveness of the EU's internal market by eliminating persisting obstacles and preventing the new ones.
- > To support the further development of the internal market in services, set the limits for further disproportionate and burdensome regulations at the national level, and continue the discussion on notifications and adequacy tests for regulated professions.
- > While completing the digital single market, prioritise non-legislative tools and eliminate the "one-size-fits-all" approach.
- > Thoroughly fulfil the goals of the European initiative of Fair and Simple Taxation, e.g. the modernisation and improvement of cooperation between tax administrations, the simplification of VAT registration, and the cultivation of the already-in-place VAT One-Stop-Shop.
- > To insist that all European legislative proposals are always based on high-quality impact assessments, e.g. in the areas of green and digital transition.

INCREASING COMPETITIVENESS AND STRENGTHENING THE EU GROWTH

- > Under the updated industrial strategy, seek to create an environment that supports the competitiveness of European industry. Also to ensure strategic technologies and products, not only through supportive policies but also by establishing the conditions for cooperation between the public and private sectors. While establishing these measures, it is necessary to ensure a level playing field, fair competition, and to encourage cooperation among companies of all sizes.
- Strive to harmonise the requirements imposed on the companies in reporting of financial and non-financial areas.
- > Pay special attention to the proposals of the European Commission regarding sustainable corporate governance and due diligence in supply chains. Ensure that regulations do not put European companies at a competitive disadvantage in a global environment and do not impose further administrative burdens.
- > Provide for an effective and flexible use of European financial tools for the post-war recovery of Ukraine.

THIRD PILLAR



EUROPE WITH A DYNAMIC LABOUR MARKET

AN INCLUSIVE AND FLEXIBLE LABOUR MARKET IN A TIME OF RECOVERY AND THE ERA OF DIGITALISATION AND GREEN TRANSFORMATION

- > Ensure coordinated support for the national adaptation of qualifications towards digital, advanced, and green skills in response to new labour market demands, and promote the EU Action Plan for digital skills 2021-2027 and the Council Recommendation on Education for Environmental Sustainability.
- > Promote the inclusivity of lifelong learning via individualised guidance and assistance for persons with difficult access to the labour market.
- Promote the new Strategic Framework for European Cooperation in the area of Vocational Education and Training, the Osnabrück Declaration, and the development of blended education at every level.

> Strengthen the EU competitiveness and jobs creation, and increase labour market flexibility, including the development of new forms of jobs, while strictly respecting and distinguishing between employment status and selfemployment.

PROMOTE THE EMPLOYMENT RATE BY INCREASING THE PREDICTABILITY OF THE LEGAL ENVIRONMENT, RESPECTING DIVERSITY, AND RESTRICTING THE ADMINISTRATIVE DIFFICULTY OF THE EUROPEAN LABOUR MARKET

- > Promote the widest possible digitalisation of administrative processes on the European labour market, in order to facilitate the application of internal market rules.
- > Respect the competence of the Member States and the autonomy of social partners in the field of wage and social protective systems. Strive to create a transparent and predictable framework for minimum wage adjustments in the Member States.
- > Promote the assurance of timely access for employers and companies to complete and current information affecting their obligation to apply the European regulations, especially in terms of cross-border activities related to providing services and the posting of workers.
- > Strengthen the uniform application of European legislation in the individual Member States so as not to violate the free movement of people, the integrity of the internal market as a whole, and to ensure a level playing field.

- > Promote diversity, participation of women in the labour market, especially by revising the Barcelona objectives, and people with disabilities in light of the EU Strategy for the Rights of Persons with Disabilities 2021-2030.
- In accordance with the new EU Occupational Safety and Health Strategy 2021-2027, ensure that the initiatives and scheduled revisions of the legislation respect companies' reality, respond to the new trends, and do not impose additional administrative and financial costs to businesses.
- > Ensure an effective use of EU tools to support swift integration and retraining of refugees from war areas and their preparedness for entering the labour market.
- > Promote the European Commission initiatives that are directed towards supporting legal migration and attracting skills and talents from the third countries (blue card, talent pool), complementarily with national preferential regimes.
- > Respect the role of social partners as actors in the labour market and prioritise solutions at company level while making maximum use of self-regulation.
