2. The total price offered in the list shall cover all the prices for matters of contract performance that are required by the tender documentation, no matter whether the list has indicated such matters clearly or not.
3. Itemized prices shall be filled out in the list in circumstances of the following : (1) The major part specified in the tender documentation ; (2) Itemized prices are required by the tender documentation for certain items ; (3) where it is a special or complex procurement without government estimate due to actual difficulties ; (4) A procurement to be awarded to the most advantageous tender ; (5) Subcontracting items ; (6) Payment by deliveries ; (7) Supply by deliveries ; (8) Spare parts for maintenance ; (9) Maintenance fee ; (10) Optional items indicated by the procuring entity, which are not included in the total price (shall indicate that they are not included in the total price) ; and (11) Suggested items indicated by the tenderer, which are not included in the total price (shall indicate that they are not included in the total price) .
