Russian Legislation Overview



- The draft law re reserving state border crossing times for trucks) was approved by the State Duma on February 9, 2023 (currently is under revision by the Council of Federation).
- The law gives the government the right to establish a list of road border crossing points, passage through which will only be possible after the reservation of the date and time. The government will also be able to establish a list of roads adjacent to such checkpoints, the passage of which by trucks will also be possible after the reservation of the date and time.
- Earlier, the bill caused a great public reaction, because initially the document did not specify what vehicles it referred to.
- Drivers will have to register each vehicle online through the state information system of electronic transport documents.
- New order will come into force on September 1, 2023.

Advertising regulation Draft law Nº247436-8

- Draft law re ban on the use of advertising the alphabets which are not based on the Cyrillic alphabet, except for indications the firm names and trademarks which have passed state registration.
- First reading not scheduled yet.
- MPs have pointed out that now advertisements were dominated by foreign-language elements and fonts, "which distorts the Russian words and the cultural code of the nation".
- The initiative sparked controversy in the Duma's Economic Policy Committee. Some MPs supported the document, while others believe that the lack of Latin characters or hieroglyphs on goods may have a negative impact on the development of entrepreneurship.

Conformity Assessment Schemes

Decision of the EEC Council of 25.01.2023 N 11

- The decision of the Council of the EEC creates conditions for organizational and administrative improvements that ease editing EAEU's conformity assessment documents (certificates and declarations).
- Earlier, in 2022, the AEB discussed with the Ministry of Economic Development the need for granting permit to use previously issued documents to legal entities that have changed their organizational and legal form over the past few months.
- Current amendments supplement the list of cases when:
 - replacement of certificates or declarations is allowed without compulsory procedures, i.e. under a simplified procedure
 - replacement of certificates or declarations is not required, i.e. certificates remain valid without making changes to them.

Medical Devices Industry

Current key

Issues



• EU sanctions: restrictions on the medical devices' export of components and spare parts from the EU to Russia.

- Japan sanctions (serious restrictions for several AEB members).
- Formation of Catalogue of goods, works, services for participation in public procurement.
- Logistic issues: closely monitoring the situation (despite humanitarian goods, still facing obstacles).
- Localization issue second is out initiatives, ad valorem share.
- Digital labeling for medical devices.



Medical Devices Industry



General License No. 6C authorizes:

- Production, sale, transportation, or **provision*** (NEW) of medical devices, spare parts and components for medical devices, as well as updating the software update for medical devices;
- Prevention, diagnosis, or treatment of COVID19 (including research or clinical studies related to COVID 19);
- **Clinical trials and other medical research activities** (NEW)
- *provision
- For example, a temporary paid/free provision of medical devices, spare parts, software for medical devices.

> Effective since 17.01.2023

General License No. 6C does not authorize:

- The opening or maintaining of a correspondent account or payablethrough account for or on behalf of any entity subject to Directive 2 under Executive Order 14024
- Prohibitions Related to Correspondent or Payable-Through Accounts and Processing of Transactions Involving Certain Foreign Financial Institutions
- Any debit to an account on the books of a U.S. financial institution of the Central Bank of the Russian Federation, the National Wealth Fund of the Russian Federation, or the Ministry of Finance of the Russian Federation
- Transactions prohibited by E.O. 14066, E.O. 14068, or E.O. 14071:

new investments in any sector of the Russian economy

export, reexport, sale, or delivery, directly or indirectly, from the United States or a U.S. Entity of dollar-denominated banknotes

any approval, financing, assistance, or guarantee by a U.S. Entity of a grantsaction that is prohibited by this section for U.S. Entities or within the United States.
