



## Working document to facilitate the monitoring and tracking of the follow-up to the Joint Declaration on the EU's legislative priorities for 2017

- At the **political level**, the implementation of the Joint Declaration will be monitored jointly and regularly through meetings of the Presidents of the 3 Institutions in March, July and November 2017;
- At the **technical level**, the implementation of the Joint Declaration will be monitored jointly and on a regular basis in the Interinstitutional Coordination Group, meeting at senior official level (*see point 50 of the Interinstitutional Agreement on Better Law-Making of 13 April 2016*).

### Initiatives for priority treatment in the legislative process
