#### **Eligibility**

Cities, academies, corporate bodies, industries, around the world are eligible to become members of GO SMART.

#### **Application Procedure**

- 1. Please complete and submit the Membership Application Form signed by the Head of executive authority to the GO SMART Secretariat.
- 2. Become the member of GO SMART upon the approval of the Secretariat after the submission of the application.

#### **Member Rights**

Members can attend GO SMART assembly, call for GO SMART Award. Exchange or request for smart city solutions, or set up SIGs (Special Interest Group) on the GO SMART platform.

#### **Member Responsibilities**

Members are obligated to abide by the Charter and resolutions of Our Organization and to pay their membership fees. Obligations of our members (excluding honorary members) are as follows:

- 1. To pay the membership fee when due. (GO SMART is scheduled to start collecting annual membership fees on March 31st, 2020.)
- 2. To appoint representatives and attend conference meetings.
- 3. To assist with the execution of resolutions passed by the General Assembly.
- 4. To facilitate the development of Our Organization as a resource-sharing platform for smart cities.
- 5. Members should maintain updated contact information with the GO SMART Secretariat at all times.
