# Approved list of top 10 priorities for active advocacy in 2023

Having considered the state of play with regard to the ongoing 2022 initiatives and the new developments foreseen in the Commission's annual work program 2023, BusinessEurope's Internal Market Policy Committee approved the following list as top 10 priorities for active advocacy in 2023, primarily focusing on *legislative* initiatives:

### **Digital Economy**

- 1. Artificial Intelligence Act (legislative, ongoing)
- 2. Data Act (legislative, ongoing)
- 3. Al Liability Directive (legislative, ongoing)
- 4. Cyber Resilience Act (legislative, ongoing)

#### **Free Movement of Goods**

- 5. EU Standardisation Strategy (legislative/non-legislative, ongoing)
- 6. Revision of the Product Liability Directive (legislative, ongoing)
- 7. NLF evaluation (Revision of Regulation 765/2008, Decision 768/2008, Regulation 2019/1020, legislative, preparation ongoing)

#### **Transport**

- 8. Revision of the Regulation on Trans-European Transport Network (legislative, ongoing)
- 9. Revision of the Combined Transport Directive (legislative, Q2 2023)

#### Governance

10. Single Market Emergency Instrument (SMEI, legislative, ongoing)
