Brief Introduction on China-CEEC Business Council

China-CEEC Business Council (hereinafter “Business Council”) is a vital part of the China-CEEC Cooperation Framework. It is a non-profit mechanism co-initiated by China and Poland in accordance with the Bucharest Guidelines for Cooperation between China and Central and Eastern European Countries 2013. And commercial associations and trade promotion agencies from the other 16 Central and Eastern European Countries have been invited to join in. On December 16th, 2014, the Third Meeting of Heads of Government of China and Central and Eastern European countries (CEECs) was held, during which the Vice Chairman of CCPIT Zhang Wei and the Director of Poland Enterprise Development Bureau Kasper Chęca signed the Memos for Joint Promotion of China-CEEC Business Council.

The executive agency was set up in PAIH and the China Secretariat was in CCPIT/CCOIC, together being responsible for the Council’s daily work. The Business Council serves as a new platform for 17+1 cooperation and a new engine for a win-win China-Europe relationship. For now, 16 commercial associations from 13 Central and Eastern European Countries have joined in the Council.
