Description of content:</b> The standard specifies terms and definitions, the limit values of energy efficiency, energy efficiency grades, technical requirements and test methods for rotary aerators in wastewater treatment.  The standard applies to the rotary aerator driven by motor or reducer, and self-suction submersible aerator connected with motor directly, dealing with all kinds of industrial wastewater, municipal wastewater biological treatment process and water source surface remediation.
