- 5. Title, number of pages and language(s) of the notified document: The Resolution of the Cabinet of Ministers of Ukraine No 884 of 17 October 2018 "On approval of the Technical Regulations on packing sets for storage and disposal of radioactive wastes" (31 page(s), in Ukrainian)
- 6. **Description of content:** This Technical Regulation specifies requirements for packing sets for storage and disposal of radioactive wastes produced as a result of the use of nuclear energy, and sets the Conformity Assessment Procedure to comply with. The Technical Regulations details the list and requirements for the documentation to be submitted by the applicant to the relevant national authority, the requirements for conformity assessment procedure are specified. The document is supplemented with a list of modules for assessing the conformity of packing sets.

According to this Resolution the Technical Regulations on Containers for Storing and Burying Radioactive Waste and Plan of Measures for Its Application" (approved by the Resolution of the Cabinet of Ministers of Ukraine of 18 July 2007, No. 939 and notified as WTO document G/TBT/N/UKR/12 of 17 December 2008) is not valid any more.
