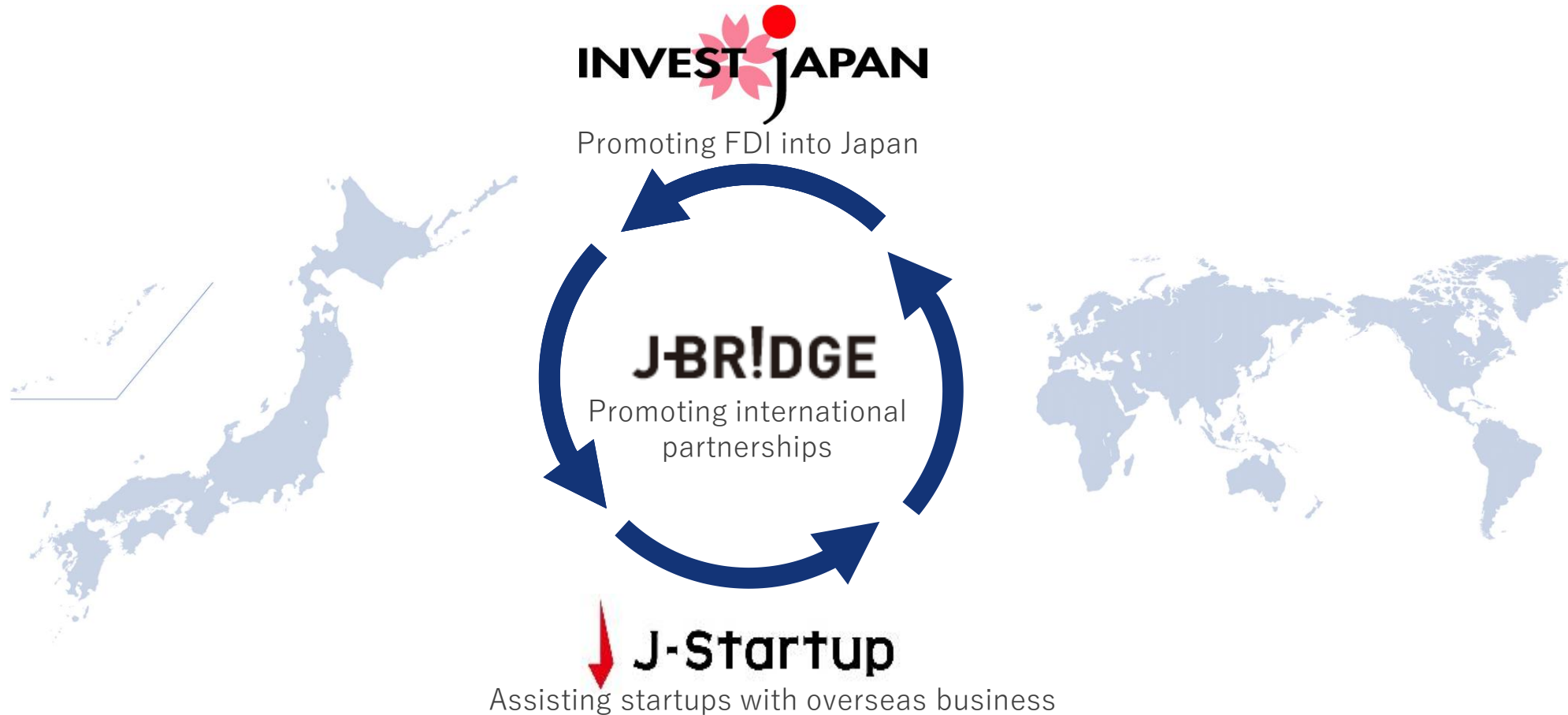

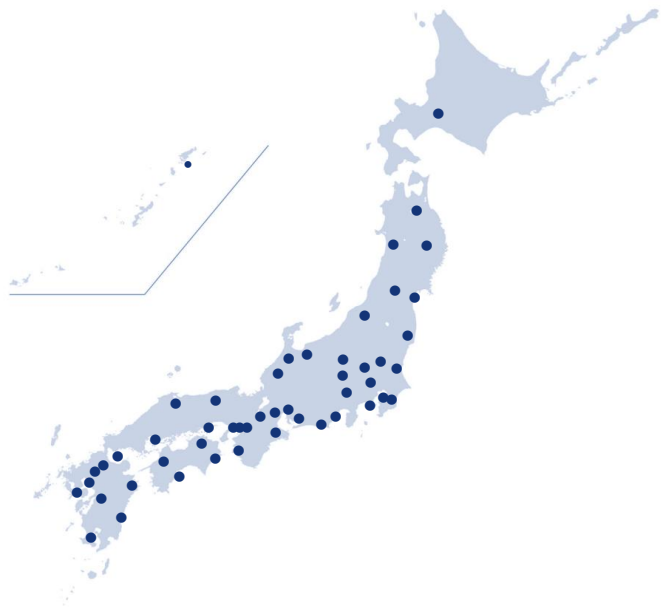
JETRO is a governmental organization that works to promote trade and investment between Japan and the rest of the world with a focus on supporting innovation
